I recognize and acknowledge that there are certain inherent risks in physical activities, like dance and related exercises, and that dance education and instruction involve kinetic corrections which may necessarily include physical touching. Sole Unique Dance Complex will take measures to provide social distancing in each class, but due to the nature of dance it may not be possible to maintain social distancing at all times. I further agree and acknowledge that I am responsible for any and all damages to the facilities, other property or persons as may be caused by any negligent, reckless, or willful actions by my child(ren) or myself. I understand the nature of the activities which I or my child(ren) will be participating in and agree that it is my responsibility to ensure that I or my child(ren) are in proper physical condition to participate.

Payment Agreement

lunderstand and agree that all account balances with Sole Unique must be up to date and paid in full in order for me or my child(ren) to participate in any dance education programs or other activities at the Facilities. All fees paid to Sole Unique Dance Complex are NON-RE-FUNDABLE. Tuition will not be refunded for missed or dropped classes. Class tuition is paid every term (eight weeks) using credit/debit card automatic payment. A \$3.00 credit card processing fee will be applied. A tuition notice will be sent via email one week prior to the payment due date. There is a \$35 late fee charged for all payments made after the first day of the term, all declined credit cards and all NSF checks. Tuition is charged/withdrawn from your account UPON ENROLLMENT and on the first day of each term. If you wish to pay by an alternate method (cash, check, credit card) you may do so prior to the first day of the new session. If there are changes to your credit/debit card on file the information must be received by the last week of the current term. If you need to withdraw from the program, a withdrawal form must be received (located at front desk) by the end of the current term. New student registration is accepted at anytime during a session and will be prorated according to the number of weeks remaining for the term. A one-time annual registration fee of \$28 is paid upon enrollment. The SUDC class season is based on five eight week terms. Some terms are shorter due to holidays and will be prorated. We do not pro-rate tuition for missed classes. Please see our Missed Class Policy. If Sole Unique Dance Complex is forced to physically close mid-term, virtual classes will be provided. Tuition will not be refunded. Classes may end a few minutes prior to the scheduled time to allow for class transitions. SUDC electronically stores your credit card number in accordance with legislated procedures. An emailed receipt with the total amount charged to your credit card will be sent to your email address on file. You may review previous
